TeamPak Agreement

TeamPaks are available for purchase to all registered Team NBL and National Teams. The Term of TeamPak Contract shall begin the day this agreement is executed ("Effective Date") and shall continue in force for one (1) year from date of contract. TeamPak Contracts are non-refundable. If Team defaults on TeamPak payments, all memberships included in the TeamPak will be suspended and Team points will be forfeited. If payment is received within 30 days of default, memberships and Team points will be reinstated.

I understand as TeamPak owner it is my responsibility to notify the NBL of any change in address, bank account information (if utilizing bank draft for payment of team dues) or credit card information/expiration date (if utilizing credit card for payment of contract). The sign-up fee is a one-time fee. I understand that the NBL has the sole authority to terminate any membership with or without notice to ensure the safety and comfort of the general membership. The NBL reserves the right to review any membership application and deny membership to any member who may pose a potential threat to the security and/or safety of other members. I will request the official rules of competition and team rules that communicate all of the benefits of a NBL membership. I further understand that NBL management has the authority to amend policies and procedures at any time to ensure the delivery of the highest possible services to the general membership.

I understand it is my responsibility to include with the TeamPak Contract a completed NBL Membership Application for every rider included in the TeamPak. The members and/or their parent or guardian must have read, agreed to and signed the National Bicycle League, Inc., Release, Waiver, Indemnification and Medical Consent Agreement provided on the Membership Application. If a rider leaves my team or I drop a rider from my team, the team manager must notify the NBL office and rider, in writing, of the change to the TeamPak. At that time, the TeamPak slot becomes vacant, and that position can be filled by a new rider of the team by submitting a completed membership application along with the riders commitment form at least seven (7) days prior to the National race in which you intend to use the rider. The rider's membership will become active the day it is **received** in the NBL office. It is the team managers responsibility for verifying that any TeamPak changes have been received in the NBL office.

I acknowledge the TeamPak agreement set forth above, and understanding the mission Statement of the National Bicycle League, Inc., hereby apply for TeamPak Contract.

Electronic Funds (EFT) or Credit Card Authorization

I authorize my bank or credit card institution to honor preauthorized Electronic Funds Transfer drawn by the National Bicycle League, Inc., on my account for (membership/program/contribution) payments as indicated. When the bank honors the EFT (or credit card) by charging my account, such transfer shall constitute notice of payment due and my receipt for the payment. Should any preauthorized EFT not be honored by said bank when received by them, then it is understood that the payment is to be made by me in the amount of said payment plus service charge. It is further understood that if such payment is not honored by the bank or credit card institution, then the NBL, at its discretion, may resubmit the amount due for payment on a future date.
